



Invitation to Bid for Purchase of Cutter and Spreader (LDRRMO)

1) The Local Government of Payao, through the General Appropriation Ordinance FY 2026 intends to apply the sum of **One Million Two Hundred Thousand Pesos Only (Php 1,200,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Purchase of Cutter and Spreader (LDRRMO)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2) The Local Government Unit Payao now invites bids for above procurement project. Delivery of the Goods is required **Fifteen (15) calendar days after the receipts of Notice to Proceed**. Bidders should have completed contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3) Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR of RA No. 12009.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 518

4) Interested Bidders may obtain further information from BAC Secretariat, LGU Payao, Zamboanga Sibugay and inspect the Bidding Documents at the address given below from 8:00 a.m to 5:00 p.m.

5) A complete set of Bidding Documents may be acquired by interested Bidders on **June 9, 2026 to June 29, 2026** from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos Only (Php 5,000.00)**.

6) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the office address indicated below, on or before **June 29, 2026 at 10:00 a.m.** Late bids shall not be accepted.

7) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.

8) Bid opening shall be on **June 29, 2026, 10:00 a.m at BAC Office, 2nd Floor, Municipal Hall Building, Payao, Zamboanga Sibugay**. Bids will be opened in the presence of the Bidders’ representatives who choose to attend the activity.

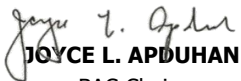
